In the preparation of their reports, the research teams may meet with human rights organizations, mental disability rights groups, community organizations and government representatives. The teams report on country

compliance with national and international standards for the treatment of persons with mental and developmental disabilities and makes recommendations for reform.

Each abstract includes bibliographic information, a 250-word abstract, and, when appropriate, information regarding the project that produced the document. The index spans research from 1956 to the present.

NIDRR Project Database: NARIC collects data on every project funded by NIDRR in a given fiscal year. Each record includes institutional and contact information, funding data, and an abstract of project goals and activities. The database includes projects funded from 1993 to the present.

The NARIC Knowledgebase: The Knowledgebase represents 25 years of collecting resources for information and referral. The database includes agencies and organizations, directories, databases, journals and other periodicals, and online resources.

Some items are available in full-text. For others, check SUMMIT to determine if the SU Library of Law Library owns the journal or document. If not, we can try to obtain it for you through Interlibrary Loan.
